She participates in clinical pharmaceutical research trials, helping to study new medications in hopes of reaching new levels of patient wellness.

for a post-meeting discussion of selected topics in small groups, using the following guide (abbreviated here for space):

FOCUS: Improving Branch health through reorganization. However, we are not interested in simply developing a new organization chart. The only required Branch officers mandated from AAUW nation are a president and a finance officer. And as a Board member said at our March meeting, the Branch will die unless we make changes.

PURPOSE: To describe/define the purpose and goals of the Atlanta Branch and to ultimately plan how we can work effectively toward our goals.

- What is your commitment to our branch and to AAUW national? (Please rate each separately)
- What current branch activities are you most passionate about?
- What is happening in the world that you think deserves support form an organization like AAUW? How could our Branch address that issue?

As a Board member said at our March meeting, the Branch will die unless we make changes.

- Based on your experience in our branch, are there activities/roles that could be done differently?
- If the branch was unable to continue, would you miss it? What specifically would you miss?
- Newer members (less than five years) only: why did you join?
- The board wants to hold a one-day retreat to fully explore the passions of this branch and possible ways to reorganize. Would you be interested in participating?

Responses to these questions were interesting and varied. Here is a sample of the answers.

- To the question about commitment to the branch and the national organization, virtually every group said they were committed to the Branch and not so much to national. One group cited commitment to equity, mission, and inspiration from others as responses.
- To the question about passion for Branch activities, all groups responded Bookfair; other responses included scholarships, community grants, RFS, women's advocacy, educational opportunities, and pay equity.
- To the questions about support for world issues and how our Branch could address them, responses included illiteracy, hunger, justice, decreasing violence against women, and pay equity; partnering with RFS was identified as a way the Branch could address some of these issues.
- To the questions of Branch activities and roles that could be done differently, responses
 included concentrating on fewer projects, fewer officers and more delegation,
 simplifying the organizational structure, and holding evening meetings.
- To the question of what you would miss about the Branch if it was unable to continue, responses included Bookfair, fellowship with other women, and support of women's education.
- To the question for newer members, responses included AAUW reputation and aggressive support of education and women's issues.
- To the question of a retreat, only one group said yes; there was concern about talking too much and taking too little action.

We need YOUR answers to these questions as we prepare for a retreat (yes, we ARE planning for a retreat on June 5) and want to ensure that the right actions will be taken to ensure Branch survival.


Board Meeting Highlights

The Atlanta Branch Board met on March 14 with thirteen members present. The meeting was long but very productive, and many important decisions were made.

- 1. Phyllis Miller brought to our attention a Whole Foods Foundation project, which provides micro credit loans to women in third-world countries. Because Whole Foods Market (Briarcliff at LaVista) has been such a great site for us and the management has been supportive, we voted to give this project \$500 from our general funds (see photos).
- 2. Approval was given to the recommendations of the Community Action committee for four recipients totaling \$4,800 (not including the award for the RFS Young Women Leaders project).
- 3. Approval was given to the recommendations of the Scholarship committee.





- 5. We nominated Huiping Du for the Emerging Leader award to be given at AAUW of Georgia's convention in April.
- 6. We are planning our observation of Pay Equity Day on April 20. Watch for more information!
- 7. The Nominating committee continues to work toward completing the slate of officers which will be voted into office and installed this spring. A discussion ensued about the projected workshop (see co-presidents' column) dedicated to discussion of branch structure and roles and responsibilities of board members.

- 8. A report about member participation in "Half the Sky" (the nationally presented program on March 4) resulted in a healthy discussion about our interest in the difficulties faced by women throughout the world. Consideration of Branch involvement in international projects is an area that could be included in our workshop.
- The Board voted to once again contribute \$250—the cost of two tickets—to the Planned Parenthood Gala on April 15. Sarah Rondeau her husband, Ed, Kay Collins, and Huiping Du will represent Atlanta Branch.

These women were selected from 28 applicants, based on the following criteria: grade point average, age (over 30), major, employment while going to school, level of family responsibilities, and their response to the essay question on the application, as well as factors revealed in their letter of recommendation. One student, Judy Khan, was selected as our first Esther Davis Scholar. Other outstanding Georgia State University undergraduates will be recognized with Esther Davis Scholarships in the future.

Much thanks goes to the scholarship committee for volunteering their time to review the applications and deliberate over the selection from an outstanding pool of applicants.
