Reauthorize the Violence Against Women Act

Since its enactment in 1994. the Violence against Women Act (VAWA) has saved many lives. According

to the U.S. Department of Justice, VAWA has contributed to a dramatic increase in the reporting of domestic violence. In addition, homicide by an intimate partner has decreased by 65 percent for women and almost 50 percent for men since the statute was enacted. In September, Vice President Joe Biden, who drafted the original Violence against Women Act, stated "Eighteen years ago today, the landmark Violence against Women Act was signed into law. It was founded

on the basic premise that every woman deserves to be safe from violence, and since its passage, we have made tremendous strides towards achieving that goal. But we still have much work to do."

Though the programs continue to run, the current VAWA authorization expired nearly two years ago. The Senate passed the AAUWsupported Violence against Women Reauthorization Act (Senate Bill 1925) by a bipartisan vote in April. It is time for the House of Representatives to do the same.

Annual BookFair Supports Philanthropy

The Atlanta Branch's hard work on our 53rd Annual BookFair has paid off. A substantial portion of the proceeds will be allocated to our Branch. Atlanta members and friends contributed 55 % of the tallied hours, Cobb members worked 27%, and North Fulton's people put in 18% of the hours worked. The final result of all of our hard work, throughout the year and at the sale, will be the distribution of \$28,367.55 to our Branch. (Final allocations are still pending review by all three Branch Presidents, but this is the anticipated amount to be awarded to the Atlanta Branch.) Overall revenues were down over last year, but continued growth in our internet sales has kept the BookFair strong.

There are many people who worked very hard to ensure a successful BookFair this year. All who contributed their time throughout the year deserves thanks, because we could not have done so well without each and every one of you. Atlanta Branch members and "Friends of the Branch" worked a grand total of 2792.6 volunteer hours on BookFair this year. A whopping 1682.6 hours of that time was spent in the Bookroom by only thirty two Atlanta members. Twenty of us worked 445 hours emptying bookdrops, sometimes in brutally hot or cold weather, and always in physically demanding conditions.

The finale was our BookFair, which required 665 hours by Atlanta members to complete.

We all owe a HUGE debt of gratitude to the three Atlanta Branch BookFair "super-workers" who continue to spend so much time on this project: Joyce Cohrs, Judy Lambert and Ellen Milholland.

Super-workers are those who contribute time which far exceeds time worked by the rest of our volunteers. But it is not just their time that is so valuable, but also their expertise which helps us maximize the value of the books our donors give to us. For that reason, our super-workers deserve the highest recognition we can award:

Violence Against Women Act ... Continued

The Senate bill addresses the needs of all victims of domestic and sexual violence, ensuring that VAWA protections are extended to men and women who are lesbian, gay, bisexual, or transgender, and to victims of violence on tribal lands. It also includes the campus safety provisions that are part of the Campus Sexual Violence Elimination (SaVE) Act, a bill that AAUW has supported for more than a year.

The U.S. Department of Justice found that 28 percent of female college students are targets of attempted or completed sexual assault. Furthermore, AAUW research reveals that two-thirds of college students experience sexual harassment. The Campus SaVE Act helps protect women on campus by

requiring colleges to establish sexual assault policies and response plans, and to publish statistics on domestic violence, dating violence, and stalking incidents.

AAUW is a strong supporter of the bipartisan VA-WA reauthorization bill passed by the Senate. Please contact your representative and ask her or him to (1) Urge the House leadership to bring an inclusive reauthorization of the Violence against Women Act to the House floor for a vote and (2) Speak out in support of the bipartisan AAUW-supported Senate-passed bill, S. 1925.
