Co President's Message

WOMEN'S HEALTH: FIRST AND FOREMOST Blondie Chitunya-Wilson

Our February Branch meeting featured Staci Fox, President and CEO of Planned Parenthood Southeast (PPSE), which serves Georgia, Alabama, and Mississippi and is headquartered in Atlanta. The mission of Planned Parenthood is to ensure that every child is a wanted child, and to protect reproductive health by providing comprehensive, medically accurate sex education and quality health care, while advocating for the right of women, men, and families.

Planned Parenthood is the largest provider of reproductive health services in the country. Staci stated that PPESE provides testing and treatment for sexually transmitted diseases, cancer screening, women's health services, and family planning. Performing abortions constitutes only 3% of services provided. The organization works tirelessly in our communities to build and strengthen relationships among social and political organizations and to protect access to healthcare and reproductive services.

Planned Parenthood is rooted in the work of Margaret Sanger, her sister Ethel Byrne, and political activist Fania Mindell who together opened our country's first birth control clinic in Brooklyn, NY in 1916. They were arrested, found guilty of distributing obscene materials and fined. But that was the beginning of a national conversation about women's rights and

just the beginning of many important milestones for providing reproductive rights , cited here:

1932 - opening of the British Control Clinical Research Bureau 1936 - court ruling that birth control devices and information would no longer be classified as obscene and could be legally distributed in New York

1948 - Development of birth control pill 1956 - First large-scale human trial of the birth control pill carried out in Puerto Rico without informed consent 1965 - 10 states legalized birth control (Griswold v Connecticut)

1970 - Planned Parenthood was able to provide birth control and sex education (Title X funding) 1973 - Supreme Court ruled in favor of abortion rights (Roe vs. Wade) 1976 - The Hyde Amendment made it illegal for the federal public to pay for abortion services except in incest, life-endangering pregnancy and rape cases 1980-1990 - Extremists staged campaigns of patient intimidation and committed acts of violence

1992 - States abortion regulations

1996 - Planned Parenthood launched plannedparenthood.org

She also develops presentations that highlight audience research insights and recommendation on how to target this audience using our digital and/or print solutions. The marketing materials are then used by the company's sales representative to sell our solutions to their clients.

Amira loves participating in all styles of dance—even hip-hop. Growing up she was in ballet and still takes classes. Her plans for future free-time include volunteering in educational settings and working with students.

What are her dreams for Atlanta Branch? She thinks a closer relationship between AAUW student chapters and our Branch would be beneficial for all. She thinks about joint meetings and events. Besides these being positive experiences, these young women are potential branch members and the future of a strong active Branch working toward equity for women and girls.

Bylaws Amendment Message from AAUW National Board of Directors

The AAUW National Board of Directors has voted to put three proposals for bylaws amendments before the membership for a vote this spring. The board strongly supports the proposed amendments that we believe will help keep AAUW vital as an organization and enable us to increase our impact in advancing equity for women and girls.

The proposed amendments address creating three-year staggered board terms, opening board service to those outside of the AAUW membership, and eliminating the degree requirement for membership. While rationale and details for each proposed amendment can be found on the AAUW website, the overarching motivation for these changes at this time is to uphold and advance AAUW's mission and ensure optimal execution at the national board level.

The first two proposals would bring AAUW's board governance structure more in line with nationally accepted nonprofit best practices and the needs of the organization. The third proposal — to eliminate the degree requirement for membership — has come before the membership for vote a number of times. The board feels strongly that while the degree requirement made perfect sense at AAUW's inception, this requirement is now perceived by many as counter to our mission and limits our ability to build the capacity needed to increase our impact as an organization.

The board recognizes that we have not traditionally put proposals up for vote outside our AAUW National Election, but these proposed changes have been under consideration for several years by both the Governance Committee and the board, and we believe it is important to move forward without delay to position the organization for greater growth. Members can comment on the proposed amendments and submit their own proposals from February 22, 2018, through March 22, 2018, at 11:59 p.m. ET. Voting will open on April 25, 2018, and close June 9, 2018, at 9 p.m. ET.

We encourage you all to engage in respectful debate that has always been a hallmark of the AAUW community, exercise your vote, and encourage fellow members to do the same. You can direct any questions or concerns to connect@aauw.org.
